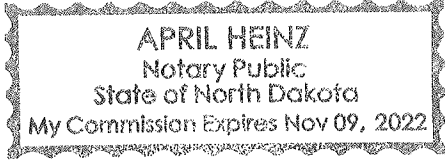

**STIPULATION FOR PROCEDURAL SCHEDULE**

Northern States Power Company and PSC Advocacy Staff hereby stipulate to the following procedural schedule:

1. Pre-filed direct testimony by PSC Advocacy Staff will be filed on or before December 1, 2021;
2. Pre-filed rebuttal testimony by Northern States Power Company will be filed on or before January 17, 2022;
3. Pre-filed surrebuttal testimony by PSC Advocacy Staff will be filed on or before February 16, 2022; and
4. Pre-filed surrebuttal testimony by Northern States Power Company will be filed on or before March 16, 2022.
5. To accommodate this procedural schedule, Northern States Power Company waives the applicability of the seven month decision deadline provided for in N.D.C.C. § 49-05-16(2) with respect to this case.

The parties hereby stipulate to an order from the Administrative Law Judge adopting the above procedural schedule.
