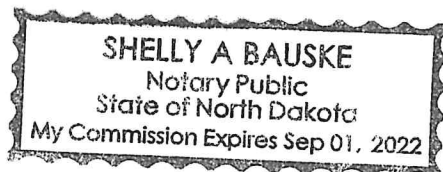


Preliminary Statement

On April 8, 1976, the Commission issued Certificate of Site Compatibility for Transmission Facility Corridor, Certificate No. 2, to Cooperative Power Association and United Power Association (CPA-UPA). Certificate No. 2 was issued in accordance with the Commission's Findings of Fact, Conclusions of Law and Order dated March 6, 1976 entered in Case No. 9322. The Commission designated a corridor for the construction, operation and maintenance of a 252.4 mile, 400 kilovolt direct current electric transmission line in McLean, Burleigh, Kidder, Stutsman, LaMoure, Ransom, Sargent, and Richland Counties of North Dakota.

On February 28, 1977, the Commission issued Permit for the Construction of a Transmission Facility, Permit No. 1, to CPA-UPA. Permit No. 1 was issued in accordance with the Commission's Findings of Fact, Conclusion of Law and Order dated December 17, 1976 entered in Case No. 9370. The Commission designated a route within the designated corridor for the construction, operation and maintenance of a 252.4 mile, 400 kVDC electric transmission line from the Coal Creek Generating Station located four miles south of Underwood, in McLean County, North Dakota, to a point on the North Dakota-Minnesota border in Richland County, North Dakota.

On July 12, 2021, Great River Energy (successor to Cooperative Power Association and United Power Association) and Nexus Line, LLC submitted a joint application for the transfer of Certificate of Corridor Compatibility Number 2 and Route Permit Number 1 to Nexus Line, LLC, Case No. PU-21-326.

On July 22, 2021, the Commission issued a Notice of Opportunity for Hearing (Notice) that provided until August 23, 2021, for comments or requests for hearing. No comments or requests for hearing were filed. The Notice stated that the Commission can determine the matter without a hearing.

The Notice identified the issues to be considered in Case No. PU-21-326 are:

1. whether Nexus Line, LLC agrees and is able to comply with the terms and conditions of Certificate of Corridor Compatibility No. 2 and Route Permit No. 1, and

By the affidavit of Stacy Tschider, President of Nexus Line, LLC, states that Nexus Line, LLC agrees to assume the rights and obligations of GRE with respect to Certificate of Corridor Compatibility No. 2 and Route Permit No. 1, agrees to comply with the conditions and limitations set forth in the Commission's March 6, 1976 Findings of Fact, Conclusions of Law and Order issuing Certificate of Corridor Compatibility No. 2 in Case No. 9322, and agrees to comply with the conditions and limitations set forth in the Commission's December 17, 1977 Findings of Fact, Conclusions of Law and Order issuing Route Permit No. 1 in Case No. 9370.

Having considered this matter, the Commission finds Nexus Line, LLC agrees and is able to comply with the terms and conditions of Certificate of Corridor Compatibility No. 2, Route Permit No. 1, and the requested transfer is compatible with the public interest.


Therefore, the Commission issues its:
