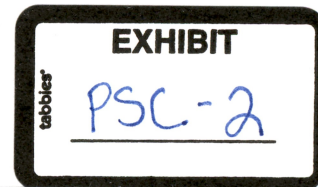
Dear Mr. Kahl,


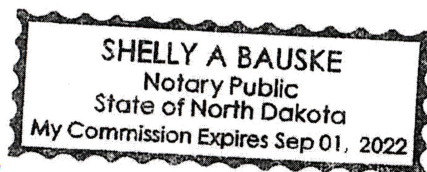

