Dear Mr. Kahl:

Dakota Natural Gas, LLC (DNG) submits this letter application for a service area addition to its tariff to the North Dakota Public Service Commission (Commission) for the Commission's consideration and approval. Included with this letter is a revised tariff sheet reflecting the additional service area which, upon approval, will replace the prior sheet identifying DNG's service areas within the State. The service area additions will take effect in 2022. This proposed tariff revision does not affect customer rates in any way.

DNG simultaneously submitted an Application for a Certificate of Public Convenience and Necessity seeking approval to extend its existing main distribution line to serve Portland, North Dakota and its environs. Upon its approval, Portland will necessarily need to be added to DNG's tariff as a service area. Since service to the Portland area will be provided pursuant to the terms and conditions of DNG's existing tariff, no other tariff changes are anticipated as a result of the Portland project and DNG's proposed tariff revision does not request any rate change.

DNG's proposed revised tariff sheet, along with a redlined version to easily identify the changes, is included herewith. DNG respectfully requests that the Commission approve the tariff revision in conjunction with approval of DNG's Application for a Certificate of Public Convenience and Necessity.
