Dear Mr. Kahl:

On November 3, 2021, the Commission issued an order ("Order") approving Caliber North Dakota LLC's October 15, 2021 request for authorization of temporary operation of facilities and facility modifications pursuant to N.D.C.C. § 49-22.1-23 (the "Variance Request"). The Variance Request pertains to Caliber's existing 2.62-mile, eight-inch natural gas pipeline located in McKenzie County, North Dakota (the "Project"). This notice is provided to correct the record. Exhibit E to the Variance Request contains a map that accurately depicts the Project's location. The Project is located in Township 150 North, Range 101 West, Section 36 and Township 150 North, Range 100 West, Sections 31 and 32. However, upon further review, the Project's corresponding legal description on page 2 of the Variance Request inadvertently references Section 29 instead of Section 31. See Docket No. 1. Similarly, the legal description in the Order also references Section 29 instead of Section 31. See Docket No. 4.

This correction does not change the nature of the Variance Request or impact the basis upon which the Commission issued its approval. As previously stated, the Project's location is accurately depicted on the Project map originally filed with the Variance Request. Caliber respectfully requests the Commission take administrative notice of the correction and/or issue a corrected Order for the limited purpose of correcting the legal description in the Order's second paragraph as follows:


