Re: Tesoro High Plains Pipeline Company LLC—Tariff Filing

Dear Mr. Kahl:

Tesoro High Plains Pipeline Company LLC (“THPP”) hereby submits for filing its oil pipeline tariff, North Dakota P.S.C. No. 122 to become effective on January 1, 2022.

THPP is filing North Dakota P.S.C. 122 to implement new committed rates and a series of corresponding uncommitted volume incentive rates for transportation services on expansion capacity that it is adding to its Connolly Gathering system in Dunn County, North Dakota (“Connolly Gathering System”). These rates were agreed to by the shipper who participated in an open season that THPP recently held to seek volume commitments for the new expansion capacity.

The transportation services agreements that set forth these rates provide that the rates will go into effect on January 1, 2022. Therefore, pursuant to N.D. Cent. Code, § 49-05-05, THPP requests that the Commission permit the rate changes reflected in North Dakota P.S.C. 122 to be effective on less than thirty days’ notice, so that they may become effective on this date. THPP submits that good cause exists for granting this request because the rates being implemented in North Dakota P.S.C. 122 were agreed to during the open season and the TSA contemplates them becoming effective January 1, 2022.

The \$50.00 filing fee is attached to this letter.

APPLICATION OF RATES FROM INTERMEDIATE POINTS: Rates from any origin not specified above to Mandan, North Dakota shall be the rate indicated for the North Dakota Station listed above that is the closest geographic point on the pipeline to the unspecified origin.

[N] Note 1: Any Uncommitted Shipper that ships one of the stated Volume Levels during a month, as calculated on an average daily basis, will qualify for the Uncommitted Rate that corresponds to such Volume Level. Any Committed Shipper whose Daily Minimum Volume Commitment in its TSA with Carrier equals or exceeds the stated Volume Level will qualify for the Committed Rate that corresponds to that Volume Level. If a Committed Shipper has a Daily Minimum Volume Commitment that varies by year, then its highest Daily Minimum Volume Commitment Level will be used to determine the Committed Rate it qualifies to pay during the duration of the TSA.

Pumpover Fee: When shipments are transferred from tank or truck facilities into the main line facilities of Tesoro High Plains Pipeline Company LLC, a charge of [U] 20.68 cents per barrel will be made in addition to the transportation rate stated above.

A [U] \$0.1085 per Barrel charge for electric power will apply to all deliveries at the following origination points: In T146N 93W: Section 11 SESW, Section 13 NWNW, Section 24 SWSW, Section 25 NWNW, and also the following locations in T145N 93W: Section 10 SWSE, Section 12 SWSW, Section 13 NWNW, and Section 15 NENW and also the following locations in T146N 92W: Section 19 SWSE, Section 30 NENW.

*The Gathering Rate for the Movement from Chimney Butte to Connolly Station is [U] 113.70 cents per Barrel. The Gathering Rate for movement on the Corral Creek Gathering System (points of origin upstream of Chimney Butte, for delivery into the Gathering System at Chimney Butte) for up to 3,200 Barrels per day (“bpd”) is [U] 37.70 cents per Barrel and the volume incentive rate for volumes greater than 3,200 bpd is [U] 34.17 cents per Barrel.

**Effective September 9, 2017 a surcharge of [U] 5.81 cents per Barrel will be applied to all deliveries to Mandan, Morton County, ND.

***Deliveries at Little Knife, Dunn County, ND for transportation to Mandan, Morton County, ND with H2S above 10 ppm shall incur a truck H2S high unloading fee of [U] 15.88 cents per Barrel.

****The rates indicated for Movements from Little Knife Zabolotny 144-98-4A-9-1H, McKenzie County, and Little Knife 8th Street, McKenzie County to Mandan, ND (Morton County) will be charged for all such Movements on the system as of September 1, 2021.
