

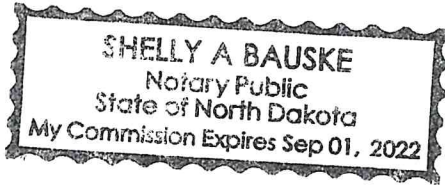

NOTICE OF OPPORTUNITY FOR HEARING

February 23, 2022

On January 27, 2022, Northern States Power Company (NSP) filed an application for revisions to its City Fee Rider tariff to incorporate the changes approved by the cities of Grand Forks and Fargo, North Dakota providing for a Franchise Fee discount to large users of electricity, and to improve the readability of the tariff. The tariff revisions would cause a decrease to some North Dakota customers.

The issues to be considered in this matter are:

1. Whether the proposed tariff changes are reasonable, and
2. Whether the tariff changes should be approved.

Those interested are invited to comment on the application in writing. Persons desiring a hearing must file a written request identifying their interest in the proceeding and the reasons for requesting a hearing. **Comments and requests for hearings must be received by April 9, 2022.** If deemed appropriate, the Commission can determine the matter without a formal hearing.
