Preliminary Statement

[1] On June 10, 2022, Badger Wind, LLC. (Badger) filed an Application for Protection of Information to protect certain information in above-captioned case.

[2] The information for which Badger seeks protection includes cultural resource location information contained in Figures 2 and 2.1 through 2.7, and the figure at the end of Appendix B of the Class III Cultural Resources Inventory, along with associated GIS data.

Discussion

[3] N.D.C.C. § 49-22-26 allows the Commission to limit access to, and release of, information that contains data that specifically identifies the location of cultural, archaeological, historical, or paleontological sites.

[4] N.D.A.C. § 69-02-09-03 provides “the commission staff shall examine the information and application, and file and serve a response that includes a recommendation on whether the information qualifies for protection.”

[5] Commission Staff believes that the application satisfies the requirements of the law, which allows the Commission to grant protection of information in this proceeding.

[6] The undersigned Hearing Officer has fully reviewed and considered Badger’s application and the recommendations of Commission Staff and has determined Badger’s application satisfies

the requirements of the North Dakota Century Code for protection of the information which is the subject of this request.

IT IS HEREBY ORDERED:

[7] The June 10, 2022 application of Badger Wind LLC for protection of information is **GRANTED.**
