At the public hearing held on June 28, 2022 on Badger Wind, LLC's ("Badger Wind") Application for a Certificate of Site Compatibility for the Badger Wind Project ("Project"), a deadline of July 28, 2022 was set for Badger Wind to file its late-filed exhibits and proposed findings of fact, conclusions of law and order. Since the public hearing, Badger Wind has learned that the State Historical Society of North Dakota ("SHSND") anticipates issuing its concurrences on Badger Wind's updated and supplemental class III cultural resource reports by mid-August.
