

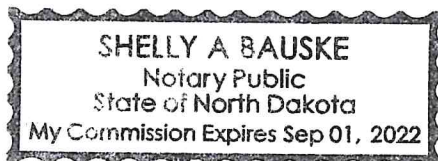

**NOTICE OF OPPORTUNITY FOR HEARING**

**May 4, 2022**

On April 6, 2022, ONEOK Bakken Pipeline, L.L.C. filed a combined application to amend Certificate of Corridor Compatibility No. 209 and to amend Route Permit No. 219 for the addition of a pump station housing three pumps to its existing Demicks Lake NGL Pipeline. The station will be located in the southwest 1/4 of Section 3, Township 148 North, Range 102 West, in McKenzie County, North Dakota, and will consist of three 5,000 horsepower electrically driven pumps. With the addition of the station, the total pipeline throughput is estimated to be 300,000 barrels of natural gas liquids per day. Future additional plants and connections could bring the total pipeline throughput to the maximum design capacity of 400,000 barrels per day.

Also, on April 6, 2022, ONEOK Bakken Pipeline, L.L.C. filed an application to waive the requirements to hold a separate hearing for the waiver application, waive any hearing requirements and instead proceed by virtue of a notice and opportunity for hearing procedure.

The issues to be considered in the application for waiver of procedures and time schedules include:

1. Is the proposed facility of such length, design, location, or purpose that it will produce minimal adverse effects and that adherence to applicable procedures and time schedules may be waived?
2. Is it appropriate for the Commission to waive any procedures and time schedules as requested in the application?

The issues to be considered in the application for an amended certificate of corridor compatibility and an amended route permit are:


1. Will the location and operation of the proposed facility produce minimal adverse effects on the environment and upon the welfare of the citizens of North Dakota?

2. Is the proposed facility compatible with the environmental preservation and the efficient use of resources?
3. Will the proposed facility location minimize adverse human and environmental impact while ensuring continuing system reliability and integrity and ensuring that energy needs are met and fulfilled in an orderly and timely fashion?

Those interested are invited to comment on the application in writing. Persons desiring a hearing must file a written request identifying their interest in the proceeding and the reasons for requesting a hearing. **Comments and requests for hearings must be received by June 3, 2022.** If deemed appropriate, the Commission can determine the matter without a hearing.
