Ms. Foerderer,

Thank you for your response to the Public Service Commission's (Commission) request for additional information letter dated March 22, 2022. I reviewed your email and discussed it with Commission Staff (Staff). Staff reviews each licensing application to ensure the applicant meets the licensing standards which include a character and fitness assessment. This is a requirement of the North Dakota Century Code section 51-05.1-02(1) which states, "Licenses may be granted only to persons who bear a good reputation for honesty, truthfulness, and fair dealing and who are competent to transact the business of an auctioneer or a clerk."

Part of Staff's review of each applicant includes a civil and criminal history review. When that review turns up cases without adequate information on file, Staff reaches out to the applicant to request further details. This gives the applicant an opportunity to explain the circumstances surrounding the case(s) along with the outcome.

Staff does not make any preliminary decisions or opinions for individuals interested in applying for an auctioneer or auction clerk license and what may constitute an approval or denial of a license. While I understand your discouragement with having completed so many steps in this process along with paying the necessary fees and premiums, Staff would not have reviewed your application at all without you completing those steps.

I encourage you to provide the requested information identified in the March 22, 2022 letter. As I understand from your previous email, both cases may still be pending; therefore, Staff is requesting the following for EACH case:

1. A statement explaining the circumstances of each incident;
2. A copy of the civil charge document; and
3. An explanation of the status of the incident to include:
 - a. Any partial satisfaction(s) of judgment, and
 - b. A statement as to your plan and timeframe of when you expect full resolution.

As a reminder, the requested information must be provided before Staff can continue with the review of your auction clerk license application.

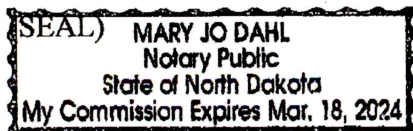
