Walmart Inc. (“Walmart”), an intervenor in this docket, respectfully moves the North Dakota Public Service Commission (“Commission”) for approval for Walmart’s undersigned counsel, Julie A. Clark, to be permitted to participate in the upcoming hearing, which is scheduled to commence on May 1, 2023, via a video conferencing platform.

Prior to filing this Motion, the undersigned contacted the parties in this proceeding and requested a response from any party with an objection. Montana-Dakota Utilities Company (“MDU”) responded that it has no objection to Walmart’s counsel participating remotely. No other party responded. Additionally, on April 20, 2023, Walmart filed its Motion for Approval for Witnesses to Testify Remotely, which was granted on April 26, 2023.

The parties in this proceeding recently reached a unanimous fair and equitable resolution of all issues that were raised or could have been raised in this proceeding in a manner consistent with the public interest and that will result in just and reasonable rates for MDU’s electric service in North Dakota. The Settlement Agreement was filed on April 26, 2023. Based on the settlement, Walmart respectfully requests that the undersigned be allowed to participate remotely at the hearing.
