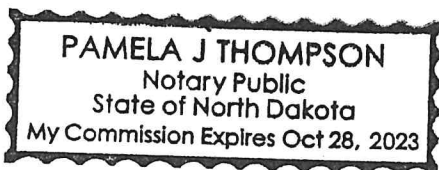




NOTICE OF OPPORTUNITY FOR HEARING

August 17, 2022

On **July 25, 2022**, Otter Tail Power Company, an electric public utility, filed an application under North Dakota Century Code Chapter 49-03 to extend service to Gilbert Vannoy at a location in Ramsey County, ND.

Submitted with the application was a statement by Gilbert Vannoy that he desires electric service to be provided by the applicant. Service is to be provided at a point located in:

**The NW 1/4 of Section 1, Twp 158N, R 63W, Ramsey County,
North Dakota.**

Otter Tail Power Company has made a prima facie showing that it should serve the customer.

Any interested party has the right to file written objection, based on the issue of public convenience and necessity, with the Commission by **September 12, 2022**, and the matter will then be set for hearing. If no objections are received by that date, the application may be granted as requested.
