Robert, Following up to your below email. The original project filings submitted by BOE and the Commission's order in PU-13-825 state the estimated cost of the project was \$14 million. I assume the inquiry relates to the administrative fee under NDCC 49-22.1-21(4)? If so appears the assessed fee would be \$1,400.00. Section 49-22.1-21(4) provides that the fee is based on each one million of "original investment" so any additional costs would appear inapplicable under the statute for purposes of calculating this fee.
