It will be very interesting to see how this plays out.

You can hear briefly from attorney Brian Jorde, Summit's attorney, and the PUC chairman--- thought this was very interesting and is a small peek into how this process works.

5. I was recently made aware of some reporting/research that has come to light surrounding the Satartia, Mississippi pipeline rupture.

A claim that we have heard time and time again was that no one was hospitalized overnight. It appears that this is not true.

This is from Dan Zegart, who reported on Satartia extensively in this article: <u>Gassing Satartia: Carbon Dioxide Pipeline Linked To Mass Poisoning | HuffPost Impact</u>

When faced with evidence of injuries at Satartia, the ethanol pipelines like to say, "But nothing serious - no one spent the night in the hospital."

My reporting showed that wasn't true, that there were several true hospitalizations, and that some victims were in the hospital for days.

Digging through the files, it turns out Denbury knew, according to their report of Feb. 24, 2020 to the National Response Center - two days after the accident - that there were [at least] 2 gassing victims still in the hospital as of the date of that report."

I've attached the relevant National Response Center report to this email to substantiate these claims. The billion dollar pipeline company has plenty of access to resources and information gathering... so the fact that they haven't been truthful surrounding this I find to be concerning.

7. Lastly, there was a lot of interest and concern surrounding federal safety regulations as it relates to CO2 pipelines at the CC meeting. I'm attaching a report and its summary that was commissioned last spring to look into this issue. It's been many months since I shared it. I think you will find it interesting/ more concrete evidence that current regulations are woefully inadequate to protect rural communities. I will also include the PHMSA Satartia report/ summary here if anyone is interested in taking another look: PHMSA Announces New Safety Measures to Protect Americans From Carbon Dioxide Pipeline Failures After Satartia, MS Leak | PHMSA (dot.gov)
