
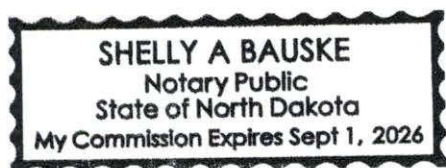

On October 17, 2022, SCS Carbon Transport LLC filed an application with the Public Service Commission for a Certificate of Corridor Compatibility and Route Permit for a pipeline, approximately 320-miles long, in Burleigh, Cass, Dickey, Emmons, Logan, McIntosh, Morton, Oliver, Richland and Sargent Counties. The Public Service Commission may not schedule a public hearing sooner than forty-five days from the date this notification is sent by mail or electronic mail. The Commission will issue a Notice of Hearing setting the hearing date.

Under North Dakota Century Code section 49-22.1-13(2)(d), political subdivisions shall provide a listing to the Public Service Commission of all local land use, zoning, or building rules, regulations or ordinances. The list of requirements must be filed at least ten days before the Commission hearing or the requirements are superseded and preempted.
