## **Application of SCS Carbon Transport LLC to Protect Information**

Pursuant to North Dakota Administrative Code ("NDAC") § 69-02-09-01, SCS Carbon Transport LLC ("Summit") submits this application to protect from disclosure certain confidential information filed with the North Dakota Public Service Commission ("Commission") in the above-captioned matter. Specifically, the purpose of this application is to protect from public disclosure certain geographic information systems (GIS) data related to the location of the proposed facilities, the proposed corridor and route, and the criteria evaluated, including, without limitation, the location of cultural, archaeological, historical, or paleontological sites (the "GIS Data") and to require any other persons or agencies who wish to view the protected information to comply with the rules and procedures set forth in NDAC § 69-02-09-07.

On October 17, 2022, Summit filed a Consolidated Application for a Certificate of Corridor Compatibility and Route Permit in the above-referenced case ("Consolidated Application"). *See* Docket No. 1, Case No. PU-22-391. Summit's Consolidated Application contained GIS Data required to be submitted to the Commission under NDAC § 69-06-05-01(2)(q).

On October 19, 2022, Summit filed with the Commission an Application for Protection of Information pertaining to the location of certain cultural, archaeological, historical, or paleontological sites set forth in Appendix 5 of the Consolidated Application (the "October 19 Application"). *See* Docket No. 5, Case No. PU-22-391.

On January 12, 2023, the Administrative Law Judge granted Summit's October 19 Application citing the Commission's authority under § 49-22.1-24 of the North Dakota Century Code to "limit access to, and release of, information that contains data that specifically identifies the location of cultural, archaeological, historical, or paleontological sites." *See* Docket No. 26, Case No. PU-22-391.

The GIS Data submitted to the Commission in the above-referenced case contains sensitive and confidential information relating the location of the proposed route and corridor and the location of cultural, archaeological, historical, or paleontological sites and therefore should be protected from public disclosure. Since it would be very difficult, if not impossible, to produce a redacted version of the GIS Data, Summit respectfully requests that the Commission waive the requirement to file a redacted version of the GIS Data pursuant to NDAC § 69-02-09-01.

Based on the foregoing, Summit requests that protection be given to any and all GIS Data submitted by Summit to the Commission in the above-referenced case. Specifically, Summit requests that the information be available only to the Administrative Law Judge, the Commission, including substitute decision makers and the Commission's counsel, and the Commission's siting analysts. In the event the Commission grants authorization to any other person or agency to view the GIS Data, Summit requests that such persons or agencies be required to comply with the rules and procedures set forth in NDAC § 69-02-09-07.
