We learned about the project from a Bismarck tribune article on or about 3/17/2022

I contacted the Tribune to see if they had a map of the route and they provided a contact at Summit, when I reached out to Summit they asked if I was a landowner since I don't appear in their system.

On March 18<sup>th</sup> I received a map from Erik Schovanec showing the Route to NOT BE ON 8N2E property, but rather on our neighbor to the South.

On about 6/1/2022 our managing partner received a phone voice mail message from Ben Schriber and she asked me to call him, I called him he returned my call on 6/3/2022. He wanted to know if it would be alright from him to survey 8N2E, I told him NO and that we do not allow anyone on the land when our renters are in active rent agreement, He said Ok but asked if anyone from Summit has been in touch with us to explain the project as to "educate us" I said NO, but that we do not allow anyone to enter our land.

On 6/6/2022 while watching an on-demand replay of the 6/6/2022 county commission meeting, Summit was presenting the project to the county and put on the overhead a photo of what they said was "the route" and that is the 1st time we ever knew about SCS re-routing from our neighbor's land and onto 8N2E..

6/7/22 I called Ben scriber and ask since he was told NOTTO ENTER 8N2E how is it possible that on 6/6/22 Summit presented a route crossing our land he said he informed summit he had been denied access, but that Summit draws lines on a map via a computer program in Ames Iowa)

On June 17<sup>th</sup> 8N2E received a call from the Sheriff office that cattle were out, and that the gate was open, (case number 22-00003928) we suspect this was intimidation from Summit. because for 71 years we never had cattle escape the pasture. (attached)

6/22/2022 8N2E letter (attached) sent to each individual member of the NDPSC, The ND Industrial Commission, District 8 ND Representative, The ND agricultural Commissioner, and Members of the Burleigh County Commission and planning commission.

On July 12 8N2E received a letter from Juile Dimeo of Summit stating that they tried "Numerous occasions" to contact 8N2E (Attached)

On July 13th 8N2E sent its response (attached)

On Aug  $2^{nd}$ , 2022, 8N2E received from Lawrence Bender a letter (dated 7/29/22) stating (falsely) that they had made numerous attempts to get our voluntary access. and that unless we give them access within 15 days they will take legal action to gain access.

On 8/11/22 8N2E replied to Lawrence Bender (attached)

On 8/27/22 8N2e send a letter directly to Wade Boeshans home address. (attached)

On Sunday 8/28/22 at 9:38 PM, the Summit lawsuit was hand delivered to the managing partner of 8N2E (attached) and we forwarded by fedEx to Dominalaw..

On 9/7/2022 My testimony to the Burleigh commission (video available)

On 9/12/22 approximately 2 weeks after they SUED 8N2E, we received an" increased offer" letter.

On 9/20/2022 I called Summit to request a face-to-face meeting to explain why 8N2E did not want any pipelines to cross its property.

On 9/21/22 Wade Boeshans, Julie Dimeo, and Dave Nehring, appeared at my home in Bismarck, and 8N2E politely explained why we will never allow this pipeline on 8N2E

January 2023 Numerous points of written and audio testimony in support for senate bills 2212, 2209, 2251, 2314

1/21/2023 received an email from Senator Keith Boehm (member of the senate energy and natural resources committee) stating the pipeline is planned for his land too and his desire to obtain the best easement and negotiate a higher payment. (attached) in no way can he be impartial should recuse and or resign.

Various dates in January and February numerous emails to various County, State and National elected officials ..

2/23/23, and 3/6/23, testimony to Burleigh County commission, (replay video available)

3/8/23 testimony to Burleigh County Planning Commission.

I urge the PSC to submit the NO ACTION alternative to reject the SCS 10/17/22 aplicatio.

The Length, design, location and purpose will have TOTAL AND MAXIMUM ADVERSE EFFECT ON OUR DEVELOPMENT PROPERTY.




Construction, operation and maintenance will cause <u>maximum adverse effect on the environment and welfare of the Rural residential development.</u>

The proposed route is <u>NOT COMPATIBLE</u> with historic and cultural features and will disrupt the ecosystem of the waterway and native unbroken prairie grass.

The construction, operation and maintenance will have MAXIMUM ADVERSE EFFECT on humans and the environment, nor does the facility provide for ANY needed /necessary energy, utility I.e., water, electricity, communication, etc.







RE: CO2 Pipeline Proposed Route

Dear Mr. Peluso:

On June 6, 2022, while observing the Burleigh County Commissioners Meeting, we were shocked to see that Summit Carbon Solutions/Midwest Carbon Express had, without notification or authorization, drawn a line on our family's ranch property, 504 acres, Burnt Creek Township, Burleigh County, indicating a proposed route for a CO2 pipeline that dissects diagonally, essentially cutting our property, which is unbroken prairie pasture, cropland and cattle ranch, in half. A plat showing the current proposed location is attached.

This is particularly disturbing since on June 3, 2022 a surveyor asked permission to enter the property to survey and he was given explicit direction that he DID NOT HAVE PERMISSION to enter or survey the land.

This property has been owned by our family for over 70 years for the purpose of farming, ranching, raising a family, and preserving the American agricultural way of life. The land, in addition to being the heart and soul of our family, was gifted with love by our parents and has immense historic significance to us. In fact, the farmstead itself could be considered for inclusion in the National Register of Historic Places.

The wooden beam Prairie Breaker plow that was used to open this prairie to farming and is on display at the North Dakota Heritage Center and Museum, was donated by Mr. Robert Morris (our father and grandfather). Additionally, the "Old Black Trail" wagon route is still visible on this prairie land, as well as the rock foundation for one of the first rural one-room schoolhouses built to serve the pioneers of our community.

Our family views this land as Sacred and in no way is in favor of anyone or any entity desecrating this land for a project that is obviously very political in nature, said to be financed with 45Q tax credits, i.e. funded with taxpayer monies.

A 24-inch high-pressure pipeline carrying toxic gases for thousands of feet on our ranch, being only 6 feet deep with 4 ft. of cover soil on a 50-foot easement is, without a doubt, inconsistent with the agricultural uses of our property and creates a significant potential danger to the many residences of nearby landowners, as well as creating a roadblock to the growth plans of the City of Bismarck.

We beg you to honor our property rights and prohibit this pipeline from placement anywhere on our property. We also demand equal protection as those who have already refuted an earlier proposed route for this debacle. This proposal to cross our property being located some 3-4 miles north of the present Costco location is ridiculous and we enlist your support to reroute this proposed pipeline.

Dear Right Of Way Manager:

8N2E received your letter on July 12 2022 you stated you have made numerous unsuccessful attempts to contact 8N2E. That is a false claim.

Your Representative Ben Schreiber contacted 8N2E by telephone and on 6/3/2022 was told that neither he or Summit had permission to enter the property, and was advised not to trespass onto 8N2E property.

A subsequent conversation on 6/7/22, he reiterated that he understood that access is denied and that he communicated that directly to Summit, so the question is did Ben Schreiber lie, or are you lying?

The multiple members of 8N2E Properties LLP are in 100% agreement that we DO NOT ALLOW Summit or any other of its affiliates, agents or contractors to enter the 8N2E property physically or by drone or any other means for any and all reasons, and will never sign the survey access form you request.

Furthermore, your publication of a pipeline route crossing 8N2E property is highly objectionable to our members inasmuch as it diminishes our current property valuation in ongoing financial work. Please be advised that you will be held responsible for all damages and losses to the full extent of the law if you persist in such unauthorized publications

Also, per contact from Burleigh County Sheriff's department 8N2E suspects that Summit did in fact trespass on the property on or about 6/17/22 and left open the gate allowing several cattle to escape.

The Summit pipeline is not wanted on 8N2E as it conflicts with our Right to Privacy and is not compatible with the planned residential subdivision.

This firm represents Summit Carbon Solutions, LLC ("Summit") in the proposed construction of a new carbon capture and storage project located in Iowa, Minnesota, North Dakota, South Dakota, and Nebraska (the "Project"). The Project will capture carbon dioxide emissions that otherwise would be emitted into the atmosphere from biorefineries such as ethanol plants, compress the captured emissions, and transport it through a pipeline to North Dakota where it will be permanently and safely stored underground in deep geologic storage locations. The pipeline, as currently designed, is expected to traverse certain portions of the above-described lands, of which you are the current owner of record. Prior to construction, Summit is required by governmental regulators to make examinations, surveys, and maps of your property to determine the most beneficial route for the pipeline.

Summit has attempted, on numerous occasions and through various means, to obtain your voluntary consent to access your property for the purpose of making such surveys to determine to gather the information it is required to submit to regulators in connection with the Project. To date, Summit has been unsuccessful at all such attempts. Summit would prefer to secure access to your property voluntarily to obtain this required information without the need of involving the courts.

Therefore, with this letter, Summit is making a final attempt to voluntarily secure permission to access your property in order to complete survey work for the Project. Enclosed are two (2) copies of a survey permission form and a self-addressed, stamped envelope. We ask that you sign one (1) copy of the survey permission form and return it in the envelope provided. The other copy of the survey permission form is for your files. If you have any questions

regarding the survey permission form or the survey work that will be performed, please contact Jeff Bryant at (701) 638-1032.

If Summit does not receive your signed survey permission form by August 15, 2022, it will have no other alternative other than to initiate a legal action to obtain access to your property for the purpose of making surveys as required by governmental regulators. This legal action will likely result in your desire to retain an attorney. Hopefully, an agreement can be reached where you and Summit can both avoid unnecessary legal costs and expenses to conduct these benign surveys.
