Silk Road Fund Participates in TPG Rise Climate Fund as Anchor Investor

On July 27, 2021, Silk Road Fund ("SRF") participated as an anchor investor into TPG Rise Climate Fund (TPG Rise Climate, L.P., the "Fund"), which has announced its first close of \$5.4 billion. The Fund, targeting to reach \$7 billion hard cap in total capital commitment, will take a broad sector approach and focus on five core sub-sectors: clean energy, decarbonized transport, greening industrials, enabling solutions, and agriculture & natural solutions.
