Dear John H. Warford Jr and Jennifer H. Warford:

As you may be aware, Summit Carbon Solutions and its affiliate SCS Carbon Transport LLC are building a pipeline in North Dakota to transport carbon dioxide. SCS has applied for a certificate of corridor compatibility and route permit with the North Dakota Public Service Commission in the above-referenced docket.

North Dakota Century Code § 32-15-06 provides that SCS and its agents have the legal right to enter onto property to “make examinations, surveys, and maps thereof” in connection with the development of its pipeline. According to our records, you are the owner of the above-referenced property. We are accordingly sending you this courtesy notice of our intent to enter the property to survey and examine it. Our expected dates of entry would be sometime between May 29 and June 30.

Recently, the North Dakota District Court for the Southeast Judicial District, Judge Narum presiding, entered an order in several cases affirming that SCS and its agents have authority under this statute to access the properties at issue in those cases for the purpose of conducting civil, environmental, and archaeological/cultural surveys and examinations, including any necessary geotechnical/soil borings.

The surveys and examinations should not inconvenience you, and we do not anticipate that they will cause any damage to the property. If damage occurs—which is unlikely—SCS will repair the damage or pay a reasonable amount for the damage, at your choice.
