SCS Carbon Transport LLC Midwest Carbon Express Project Update to Data Request 3.3

Dear Mr. Kahl:

On October 17, 2023, the North Dakota Public Service Commission ("Commission") submitted certain supplemental filings ("Supplemental Filings") and data requests ("Data Requests") to SCS Carbon Transport LLC ("Summit") in the above-referenced case. *See* Docket No. 409. Summit timely filed its response to the Data Requests on October 31, 2023 (the "Response to Data Requests"). *See* Docket No. 411.

Data Request 3.3 provides:

"Please identify what percentage of easements have been obtained by county."

As set forth on Exhibit A attached hereto, Summit has made notable progress in its right-of-way acquisition efforts since October 26, 2022, the date of Summit's right-of-way acquisition summary in its Response to Data Requests. Summit will continue to update the Commission with respect to its right-of-way acquisition efforts.
