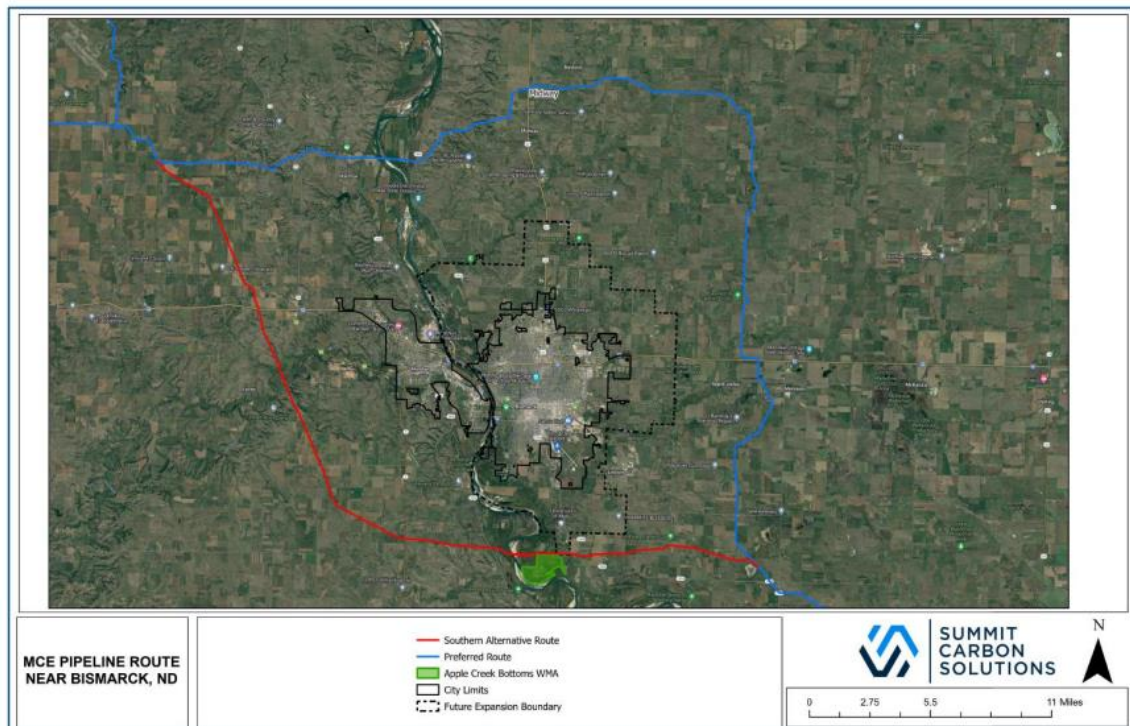


Figure 4: Overview Map of Preferred Route and Southern Alternative Route
