
**Response of SCS Carbon Transport LLC to the Petition to Intervene
by Randall Waloch, Karla Waloch, Lugert Land Limited Partnership, CarolLee Carruth
and William Carruth**

On March 21, 2024, Randall Waloch, Karla Waloch, Lugert Land Limited Partnership, CarolLee Carruth and William Carruth (collectively, the “Landowners”) filed a Petition to Intervene in the above-captioned case. *See* Docket No. 464. SCS Carbon Transport LLC (“Summit”) has no objection to the Landowners intervening in this case for the limited purposes of addressing the deficiencies set forth in the August 4, 2024 Order (Docket No. 375) of the North Dakota Public Service Commission (“Commission”). For avoidance of doubt, Summit objects to the Landowners intervening for the purpose of addressing, or attempting to address, matters which (i) are outside of the jurisdiction of the Commission, including, without limitation, private easements matters, eminent domain, safety compliance with PHMSA construction and operation, and permanent sequestration and storage of carbon dioxide,¹ or (ii) any matters in the August 4, 2024 Order (Docket No. 375) of the Commission which the Commission determined Summit has sufficiently addressed.


