It is wholly unfortunate that you could not see your way to accommodating BURLEIGH County's request to reschedule the upcoming Public Hearing date that you all scheduled without coordinating with the Intervenor Attorneys while ensuring there were not only no conflicts with you and your staff but ALSO no conflicts with Summit Carbon Solutions vast number of legal counselors and expert witnesses.

The preferential treatment by you toward Summit throughout this entire Docket and numerous Hearing process has been glaring. All you need do is watch (especially) Commissioner Christmann's treatment of many public witnesses and intervenor witnesses on March 14, May 9 and June 2 2023 and this latest utter disregard (and disrespect) toward Intervenor Emmons and BURLEIGH County with the latter now not able to have its legal counsel available for the April 22, 2024 Public Hearing.
