

NOTICE TO APPELLANTS OF ESTIMATED COSTS

[¶ 1] Under North Dakota Century Code Section 28-32-44(2), when a Public Service Commission decision is appealed, the Public Service Commission shall notify the appellants of the estimated costs of preparing and filing the record. The appellants must then pay the Public Service Commission the amount estimated. If the actual costs are more than the

estimated costs, the appellants must pay the difference. If the actual costs are less than the estimated costs, the Public Service Commission will refund the difference.

- [¶ 2] PLEASE TAKE NOTICE that because the existing record will be provided in an electronic format, there will be no costs for preparing and filing the existing record. However, since there is only an electronic copy of the formal hearings and prehearing conferences available in the Public Service Commission's docket, a written transcript of the hearings, the electronic record must be transcribed by a private transcription service.
- [¶ 3] The estimate the Public Service Commission has obtained from a private transcription service to transcribe the proceedings, for certified original transcripts, concordances and electronic versions, is forty-nine thousand eight hundred eighty dollars (\$49,880.00). The transcription service is estimated to be completed in three and one-half months.
- [¶ 4] If the Appellants requests the transcript, please notify the Commission and remit the estimated cost.
