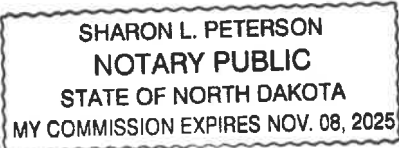

The meeting was called to order at 9:00 A.M. by Chairman Ouradnik with Commissioners Teske and Sonsalla present.
 Commissioner Sonsalla presented a motion to approve the minutes of the February meeting as presented. The motion was seconded by Commissioner Teske and passed with all in favor.
 Discussion was held on the resignation of Shelby Hewson as the Extension Agent for Slope County. Commissioner Teske presented a motion that a new county agent with an Ag and Natural Resources focus be hired. The motion was seconded by Commissioner Sonsalla and passed with all in favor.
 Commissioner Teske will represent the board of county commissioners on the hiring committee.
 Rory Teigen, Slope County Sheriff,

and Nathan Miller, Slope County Road Foreman, met with the commission to request an end of probation pay increase for Lynelle Jacobson. Commissioner Teske presented a motion to increase Lynelle Jacobson's salary by an amount equivalent to \$.50 per hour. The motion was seconded by Commissioner Sonsalla and passed with all in favor.

Rory Teigen, Slope County Sheriff, discussed the Forest Service law enforcement agreement with the commissioners.

Nathan Miller, Slope County Road Foreman, discussed the Forest Service wanting to buy gravel from the Fish pit. The purchase was approved. Also discussed were the specs for the proposed shop addition which will be bid at the April meeting.

Colleen Germann, Slope County Treasurer, presented the February bank statements.

At 9:30 Lynelle Jacobson was interviewed for the VSO position, Shelby Hewson, Slope County Extension Agent, met with the commissioners to discuss the position for the new agent. Also discussed was Extension wanting to hire and FCW agent for the Adams/Bowman/Slope area.

At 10:00 A.M. culvert bids from Contech Engineered Solutions and True North Steel were opened.

A discussion was held by phone with Jim Gray, NDSU Extension, concerning the hiring of a new extension agent and the desire to get the recruitment process started.

At 10:15 A.M. fencing bids from ABC Fencing were opened.

Dirt work bids from Fisher Sand & Gravel, Knife River, Iron Horse Construction, Wilson Construction, Kevin Miller Construction, Beylund Construction, Melvin Miller Construction, Baranko Brothers, Hlebechuk Construction, and Edward H Schwartz Construction were opened at 10:30. Due to the inclement weather, approval of bids was held in case there are more in the mail that have not arrived.

Loren Jacobson, Gary Van Daele, John Wolfgram, Matt Burke, Tom Bakken, Shem & Dwight Iverson, met with the commissioners to discuss the use of their roads by the powerline company and to ask that they be kept off of the road by Jacobson's.

Tom Bakken, met with the commissioners to interview for the VSO position. Kelly Turbiville and Dennis Rice, Marmarth School Board members, met with the commissioners to discuss the possibility of a joint position for the County Superintendent of Schools and the Marmarth School Principal.

The meeting was recessed for lunch at 12:45 and reconvened at 1:30 with all commissioner present.

At 1:30 Alacia Coates met with the commissioners to interview for the VSO position.

At 2:00 P.M. Suzanne Reddick met with the commissioners to interview for the County Superintendent of Schools position.

Discussion was held on forming a joint County Superintendent of Schools/Marmarth Principal position and possible salary.
