**NOTICE OF APPLICATION
FOR REVISION TO A SURFACE COAL MINE PERMIT**

Please take notice that Westmoreland Beulah Mining LLC, PO Box 39, Beulah, North Dakota 58523, has made application to the North Dakota Public Service Commission for Revision No. 35 to Surface Coal Mining Permit KR5B-8603. Revision No. 35 proposes to modify reclamation schedules for the Silver, Gold, and Iron pits. Revision No. 35 also will update the water management plan to include newly constructed ponds, and update the certified leases and agreements.

The permit area is located in Sections 14, 15, 16, 17, 18, 19, 20, 21, 22, 23, and 29, T.143N., R.88W., Mercer County, North Dakota. This area is contained on the United States geological survey map named Medicine Butte, N.E., North Dakota. The precise location and boundaries of the permit area are depicted on the accompanying map.

This application is on file in the Office of the Director, Reclamation Division, Public Service Commission, State Capitol, Bismarck, North Dakota and the Office of the County Auditor, Mercer County, Stanton, North Dakota. 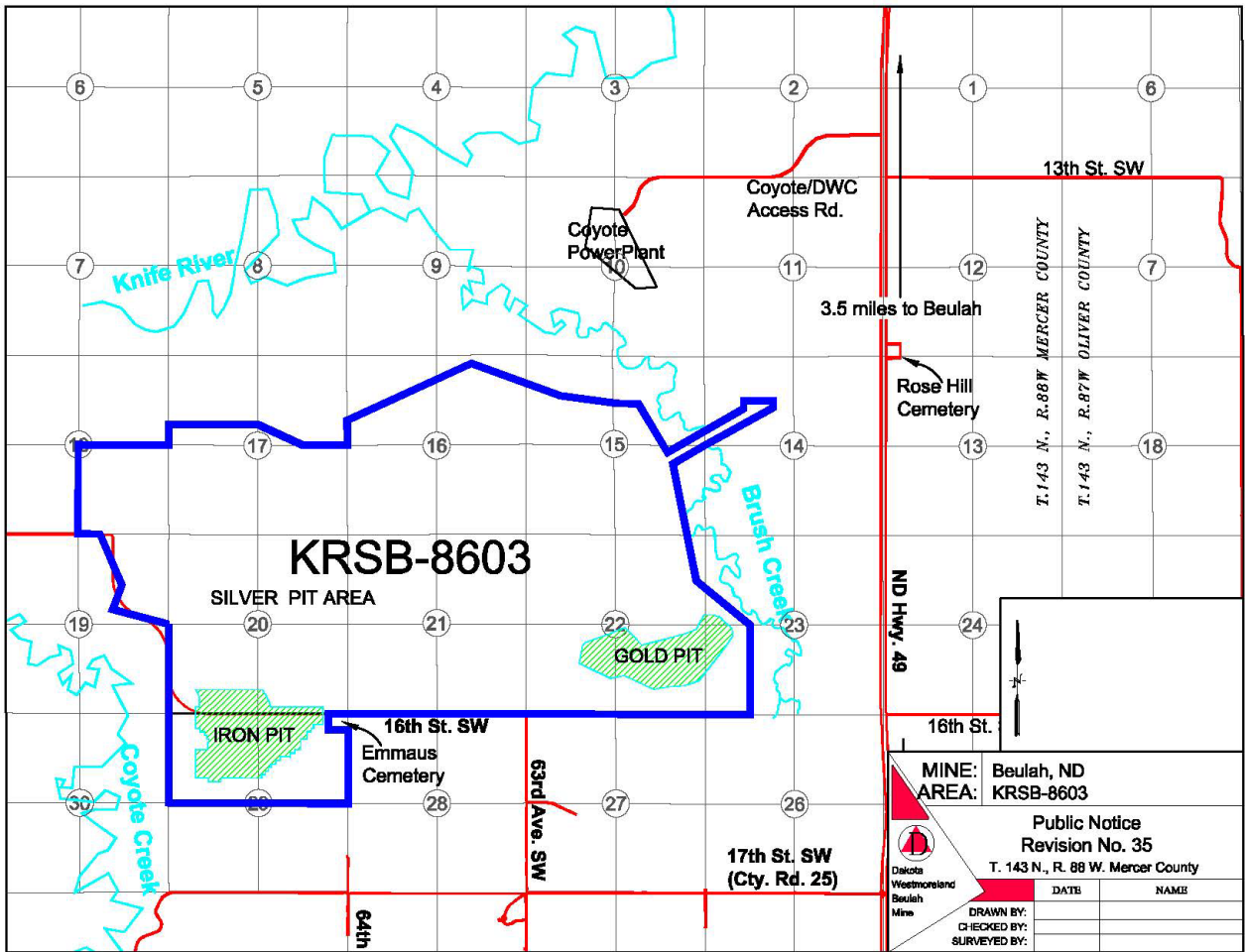
