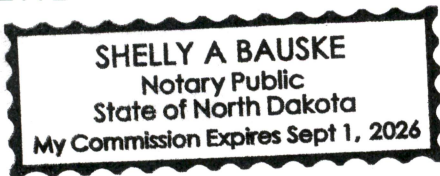

Westmoreland Beulah Mining LLC has filed an application to revise Surface Coal Mining Permit No. KRSB-8603 covering lands located in:

**Portions of Sections 14, 15, 16, 17, 18, 19, 20, 21, 22, 23, and 29,
T143N, R88W, Mercer County, North Dakota.**

Revision No. 35 proposes to modify reclamation schedules for the Silver, Gold, and Iron pits. Revision No. 35 also will update the water management plan to include newly constructed ponds and update the certified leases and agreements. All coal has been removed from within the permit. The revision application and surface coal mining and reclamation permit may be inspected at:

You may submit written comments or objections on the proposed revision application and its effects on the environment and on surface owners of the land in the permit area. You may request an informal conference with the Commission and the applicant on the revision application. The reasons for requesting an informal conference must be stated in the request. Written comments, objections, or requests for informal conference must be made by June 19, 2023.

If there is an informal conference, you may request a formal administrative hearing on the Commission ruling on the application. Your request for a formal hearing must be made within thirty days of the Commission ruling on the application.
