

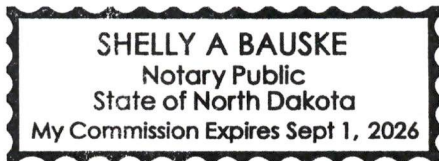

On **July 28, 2023**, Otter Tail Power Company, an electric public utility, filed an application under North Dakota Century Code Chapter 49-03 to extend service to Travis Benson at a location in Eddy County, North Dakota.
