OIL PIPELINE TARIFF FILING

Re: Bridger Pipeline LLC—Tariff Filing

Dear Mr. Kahl:

Bridger Pipeline LLC (“Bridger”) hereby submits for filing its oil pipeline tariff, North Dakota Tariff No. 4 to become effective on July 1, 2023. North Dakota Tariff No. 4 cancels and replaces Bridger’s current North Dakota Tariff No. 3.

Bridger is filing Tariff No. 4 to adjust its rates in accordance with the Federal Energy Regulatory Commission’s (“FERC”) annual index. Specifically, FERC issued its Notice of Annual Change in the Producer Price Index for Finished Goods, 183 FERC ¶ 61,096 (2023), which established the index adjustment of positive 1.133194 that is applicable to the period July 1, 2023 to June 30, 2024 (“July 2023 Index”). As such, Bridger has increased its rates in the tariff to reflect application of the July 2023 Index. The \$50 filing fee is included in this filing.

Gathering Charge: The rates for both Routes include gathering services. Crude petroleum having a vapor pressure in excess of 14 pounds absolute (psia) at a temperature of 100 degrees Fahrenheit or which has an API gravity of less than 34.0 degrees will not be accepted.

A deduction of one-quarter percent (0.25%) will be made for evaporation and loss during transportation for the movement from tanks connected to Carrier's facilities located in Dunn County, ND to Tesoro High Plains Pipeline Highway 22 Station.

In addition to all other applicable charges for movements listed herein, a Truck Unloading and handling fee of **[I] 14.80** cents per barrel shall apply to all crude petroleum delivered by tank truck into the facilities of Carrier.
