Pursuant to N.D.A.C. § 69-02-09-01, Otter Tail Power Company (Otter Tail) submits this application to protect from disclosure certain confidential information filed with the North Dakota Public Service Commission (Commission) in the above-captioned matter. The purpose of this application for protection of information is to protect from public disclosure cultural resource location information pursuant to N.D.C.C. § 49-22-26 (“The [C]ommission may limit access to, and release of, information that contains data that specifically identifies the location of cultural, archaeological, historical, or paleontological sites.”).


Specifically, Otter Tail requests that protection be given to the cultural resource location information in the Figures to the *Class I Literature Review – Cultural Resource Report and Unanticipated Discoveries Plan* (Exhibit A, Appendix E to the Certification of Timothy J. Rogelstad), along with associated GIS data. Specifically, Otter Tail requests that the information be available only to the Commission, the Commission’s counsel, the Commission’s siting analysts, and the Administrative Law Judge (should one be designated).

Two (2) hard copies and an electronic version of the unredacted, non-public version of *Class I Literature Review – Cultural Resource Report and Unanticipated Discoveries Plan* are being provided with this request. Also provided is a USB drive containing non-public GIS data. The redacted public version of *Class I Literature Review – Cultural Resource Report and*
