All of the allegations of the Application herein are admitted as true and correct.

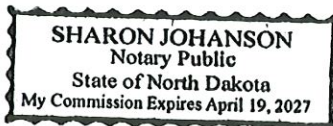

This Application is made pursuant to the provisions of Chapter 49-03, NDCC, as amended, and the Rules of Practice and Procedure promulgated by the Commission.

**III.**

Applicant has been requested by Chris Paulson  
(hereinafter referred to as the Customer), to provide electric service to it at a point located in

Fresh Water Township, Ramsy County, North Dakota, as shown on the attached

The service required by the Customer at said location is single phase service, and the length of the extension will be approximately 225 feet, as shown by Exhibit "A". It is Applicant's public utility obligation to furnish the requested service, and the public convenience and necessity require, and will be subserved by, Applicant furnishing the requested electric service to this Customer at said location.

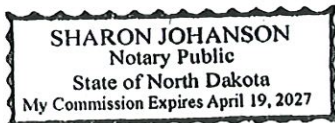
