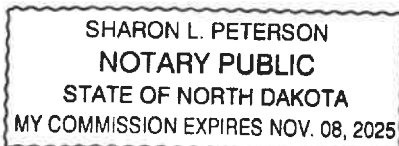

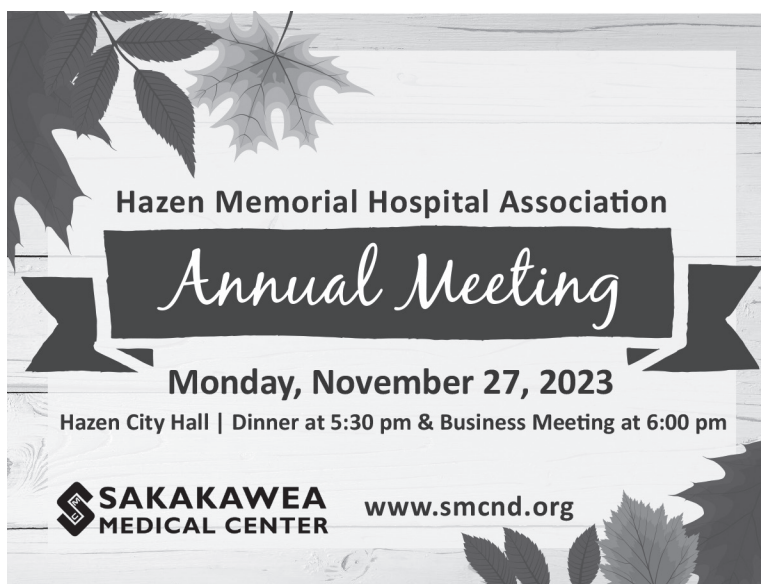

After advancing to the quarterfinals in the Class B Region 7 volleyball tournament Nov. 6, the Hazen Bison ended their season.

Regionals kicked off for Region 7 on Nov. 3, which included Beach, Beulah, Bowman County, Dickinson Trinity, Glen Ullin/Hebron, Hazen, Heart River, Hettinger/Scranton, Killdeer, Mott-Regent, New England and Richardton-Taylor.

The Hazen Bison put up a good fight during the tournament.

Number eight Hazen took on number nine New England Nov. 3 advancing after a 3-0 sweep.

However, it was the quarterfinals where the

Bison lost steam, and just like Beulah, fell to the number one seed.

Hazen was defeated by Dickinson Trinity 0-3.

Beulah had a bye in the first-round games, advancing them immediately to the quarterfinals.

The number two Miners took on number seven Mott-Regent and swept them in a 3-0 game Nov. 6.

The next day, Beulah took on number three Hettinger/Scranton advancing to the finals with a 3-1 game win.

Number one Dickinson Trinity ended Beulah's run Nov. 9 after the Miners fell 0-3.
