Liz,

This looks great.

Thanks for attaching the ND Estimate to indicate it will be published in the **Center Republican (Hazen, North Dakota)** one time. Because the deadline was missed causing noncompliance with the law (see below NDCC § 28-32-10(5)), please publish the attached notice for extended comment as we attempt to establish substantial compliance and avoid having to reissue the notice statewide and hold another hearing due to the error of this publication.

North Dakota Century Code § 28-32-10(5):

“At least twenty days must elapse between the date of the publication of the notice and the date of the hearing. Within fifteen business days after receipt of a notice under this section, a copy of the notice must be mailed by the legislative council to any person who has paid the annual fee established under subsection 4.”

Note that the publication of the notice must be in a display-type format with a minimum width of one column of approximately two inches [5.08 centimeters] and a depth of from three inches [7.62 centimeters] to four inches [10.16 centimeters].

Do not publish in the classifieds. Please run it as a "News Item Only" article as well.

Send the electronic tear sheet and electronic Affidavit of Publication, to the North Dakota Public Service Commission to the ndpsc@nd.gov email address. **We expect there to be no bill for the publication in this newspaper because of noncompliance.**
