**ORDER ON ELIGIBLE TELECOMMUNICATIONS CARRIER DESIGNATION**

**October 11, 2023**

On October 9, 2013, the Commission's Order on Eligible Telecommunications Carrier Designation designated Boomerang Wireless, LLC (Boomerang) as an eligible telecommunications carrier (ETC) for the purpose of receiving federal universal service support for low-income consumers under 47 CFR Part 54 Subpart E in North Dakota wire centers. The Commission's October 9, 2013, Order designated Boomerang as an ETC in all study areas in North Dakota.

On July 28, 2023, Boomerang filed an application with the Commission, under 47 U.S.C. section 214(e)(4) and 47 C.F.R. section 54.205, requesting partial relinquishment of its designation as an ETC in areas served by the underlying network of Verizon Wireless.

Under 47 U.S.C. section 214(e)(4) and 47 C.F.R. section 54.205, the Commission shall permit a carrier to relinquish its ETC designation for an area served by more than one eligible telecommunications carrier.

Prior to permitting a telecommunications carrier designated as an eligible telecommunications carrier to cease providing universal service in an area served by more than one eligible telecommunications carrier, the state commission shall require the remaining eligible telecommunications carrier or carriers to ensure that all customers served by the relinquishing carrier will continue to be served, and shall require sufficient notice to permit the purchase or construction of adequate facilities by any remaining eligible telecommunications carrier. The state commission shall establish a time, not to exceed one year after the state commission approves such relinquishment under this section, within which such purchase or construction shall be completed.

On August 16, 2023, the Commission issued a Notice of Opportunity for Comment providing until close of business on September 29, 2023, to receive comments. No comments were received.

The Commission has reviewed the documents in this proceeding and finds:

1. There is more than one ETC serving in the area Boomerang is seeking to relinquish. The alternative ETCs include Life Wireless, NDNC, BEK Communications, AT&T Mobility, Verizon Wireless, Centurylink, Red River Communications, Polar Communications, Midcontinent Communications, United Telephone Mutual Aid Company, Midstate Communications and Reservation Telephone Cooperative.
2. Boomerang provided advanced notice to the Commission of its intent to relinquish its ETC designation for the following zip codes in North Dakota:

3. There are 15 subscribers currently being served by Boomerang in the area it intends to relinquish. Those subscribers have the option to port their service to an alternative zip code that Boomerang is not relinquishing or to select a different ETC that serves their area. Boomerang will send notices to each subscriber 60, 45, 30, 15 and 5 days prior to its proposed relinquishment date of October 20, 2023.

### Order

The Commission orders that Boomerang Wireless, LLC's relinquishment of its October 9, 2013, designation as an essential telecommunications carrier is permitted for the requested zip codes in North Dakota effective October 20, 2023.
