Following the filing of the Applications to the Commission, Oliver Wind IV has had additional correspondence with the following agencies provided in the table below and in Attachments 1-3. Oliver Wind IV previously provided updated correspondence with the North Dakota Game and Fish Department, U.S. Fish and Wildlife Service, and North Dakota Department of Agriculture in the Wildlife Coordination and Mitigation Measures Memorandum, submitted to the Commission and filed under PU-23-317 (Dkt. No. 13) and PU-23-318 (Dkt. No. 15).

Oliver County	November 16, 2023	Oliver County Planning and Zoning passed a motion with a 4-0 vote sending a do pass recommendation for approval of Oliver Wind IV's wind energy center and 11-mile transmission line conditional use permit applications.
	December 7, 2023	Oliver County Commission voted to approve Oliver Wind IV's wind energy center and 11-mile transmission line conditional use permit applications. The CUP was submitted to the Commission and filed under PU-23-317 (Dkt. No. 16) and PU-23-318 (Dkt. No. 18).
Mercer County	October 19, 2023	Mercer County Planning and Zoning passed a motion with a 5-0 vote sending a do pass recommendation for approval of Oliver Wind IV's 9-mile transmission line conditional use permit application and the variance request (to align county procedure with Commission procedure of consolidating the corridor and route into one application) conditioning approval on obtaining easements from Great River Energy and Basin Electric.
	November 1, 2023	Mercer County Commission voted to approve Oliver Wind IV's 9-mile transmission line conditional use permit pending proper signatures and notary of the last two landowners. The CUP was submitted to the Commission and filed under PU-23-317 (Dkt. No. 16) and PU-23-318 (Dkt. No. 18).
State Historical Society of North Dakota (SHSND) (Attachment 1)	December 7, 2023	Oliver Wind IV received from the SHSND an architecture report acceptance letter and an architecture report concurrence/determination letter. The SHSND concurred that 32OL916 and 32OL888 are significant architecture sites. The SHSND noted that the adverse effect from the wind energy center to the architecture sites could be mitigated by the documentation of the sites during a State Historic American Buildings Survey (HABS) Level III.
	December 20, 2023	Oliver Wind IV, SHSND, and Burns & McDonnell meet to confirm HABS Level III will serve as mitigation for sites 32OL888 and 32OL916.
