**CERILON GTL ND INC.'S APPLICATION
FOR PROTECTION OF INFORMATION**

Pursuant to N.D. Admin. Code § 69-02-09-01, Cerilon GTL ND Inc. (“Cerilon”) submits this Application for Protection of Information to protect from public disclosure certain confidential information filed with the North Dakota Public Service Commission in Case No. PU-23-325. North Dakota Century Code Sections 49-22-26 and 49-22.1-24 state “[t]he commission may limit access to, and release of, information that contains data that specifically identifies the location of cultural, archaeological, historical, or paleontological sites.” The information subject to this request includes study and survey information discussing and depicting the location of cultural resources.

On October 5, 2023, Cerilon filed an application for a Certificate of Site Compatibility relating to the Cerilon GTL North Dakota Project. Docket No. 1 (the “Siting Application”). The Siting Application inadvertently included a non-public Appendix F Class I and Class III Cultural Inventory Report (the “Non-Public Report”) depicting the location of cultural resources. The Non-Public Report has since been removed from the Siting Application’s Appendix F on the Commission’s online docket.


Pursuant to N.D.C.C. §§ 49-22-26, 49-22.1-24, Cerilon requests the Non-Public Report be protected from public disclosure. Cerilon requests that access to the Non-Public Report be limited

to the Commission, Commission counsel and staff, and the Administrative Law Judge subsequently assigned to this case. In accordance with N.D. Admin. Code § 69-02-09-02, one hard copy of the Non-Public Report is included herein and marked PROTECTED INFORMATION - PRIVATE.

Pursuant to N.D. Admin. Code § 69-02-09-01(5), Cerilon is providing a redacted, public version of the cultural resources report. An electronic pdf and eight hard copies of the redacted public report are enclosed. The REDACTED Class I and Class III Inventory Report serves as a replacement to Appendix F of the Siting Application.
