- [3] N.D.A.C. § 69-02-09-03 provides "the commission staff shall examine the information and application, and file and serve a response that includes a recommendation on whether the information qualifies for protection."
- [4] Commission staff filed a Response to the Application dated April 11, 2024. The staff believes that the application satisfies the requirements of the law which allows the Commission to grant protection of this information.
- [5] N.D.C.C. §§ 49-22-26 and 49-22.1-24 both provide that "the commission may limit access to, and release of, information that contains data that specifically identifies the location of cultural, archaeological, historical, or paleontological sites."
