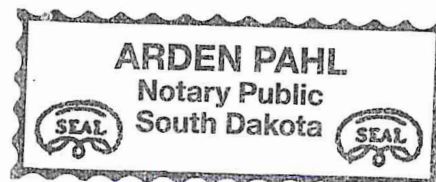

NOTICE OF FILING A PERMIT RENEWAL AND REVISION TO CONDUCT SURFACE COAL MINING AND RECLAMATION OPERATIONS

The Coteau Properties Company, 204 County Road 15, Beulah, North Dakota 58523, as application, has filed an Application for Renewal of Permit NACT-0201 with the North Dakota Public Service Commission. The current permit area covers portions of Sections 2, 3, 4, 5, 6, 7, 8, and 9 of T144N, R88W; Sections 1 and 12 of T144N, R89W; Sections 30, 31, and 32 of T145N, R87W; and Sections 3, 4, 9, 10, 11, 14, 15, 16, 21, 22, 23, 25, 26, 27, 28, 33, 34, 35, and 36 of T145N, R88W, of the Fifth Principal Meridian, Mercer County, North Dakota. The total acreage within the permit area is approximately 17,170.7 acres. The permit term will be from April 14, 2024 to April 14, 2029. The Coteau Properties Company has also filed an application for Revision 28 to Permit NACT-0201 with the North Dakota Public Service Commission. This revision identifies the coal removal subarea that will be mined during the next five-year permit term, and addresses all operational changes proposed during the next permit term. Federally owned coal, located in the E 1/2 of Section 4, T145N, R88W and the E 1/2 of 12, T144N, R88W will not be mined until Federal Mine Plan Approval is received from the Office of Surface Mining (OSM). Updates have been made to the introductory information, legal information, business entity/compliance information, identification of interests and rights of entry, surface water hydrology, ground water hydrology, soil resources, fish and wildlife resources, operations – general, transportation facilities, surface water management, post-mining land use plans, revegetation procedures, establishment, and management, post-mining wetlands. The permit area is approximately three miles north of Beulah, and approximately two miles north of Zap, North Dakota. The newspaper publication notice map shows the distance to the cities of Beulah and Zap, North Dakota, and the outline of the permit area.
