Dear Cleo and Jan:

As a part of the Basin Electric's Round-up to Kummer Ridge Transmission Line Project, we are required by the North Dakota Public Service Commission (ND PSC) to quantify the trees and shrubs that were removed during the construction of our Project.

The inventory for your parcel(s) indicate the following trees and shrubs were removed due to our construction activity:

Number of Trees & Shrubs	Replacement 2:1
31	62

The trees and shrubs are to be replaced at a 2:1 ratio with 2-year-old saplings or shrubs by the same or similar species suitable for North Dakota growing conditions as recommended by the North Dakota Forest Service and by your County Soil Conservation Service. Based on the requirement to replace the removed trees at a 2:1 ratio, you are entitled to the above number of trees and/or shrubs (your discretion) of the recommended species.

You have the choice of having the replacement trees planted off of the transmission right-of-way on your property, or waiving this requirement and allowing the trees/shrubs to be planted on other parcels near the project. If you waive this requirement, you will be compensated ten dollars (\$10.00) per tree (\$250 minimum). Basin Electric will coordinate all tree plantings through the local county Soil Conservation Service. Tree plantings would most likely be scheduled for 2025.

Please respond by October 31, 2024, by signing and noting your preference on the enclosed return form. In the event that no response is received, Basin Electric will proceed as though you waived the tree replacement program on your property and the damage compensation of \$10.00 per tree (\$250 minimum) will be mailed to you within fourteen days of receipt of this signed letter agreement. Due to the number of trees removed from your property at the 2:1 replacement ratio, your compensation amount will be \$620.00
