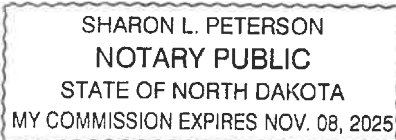

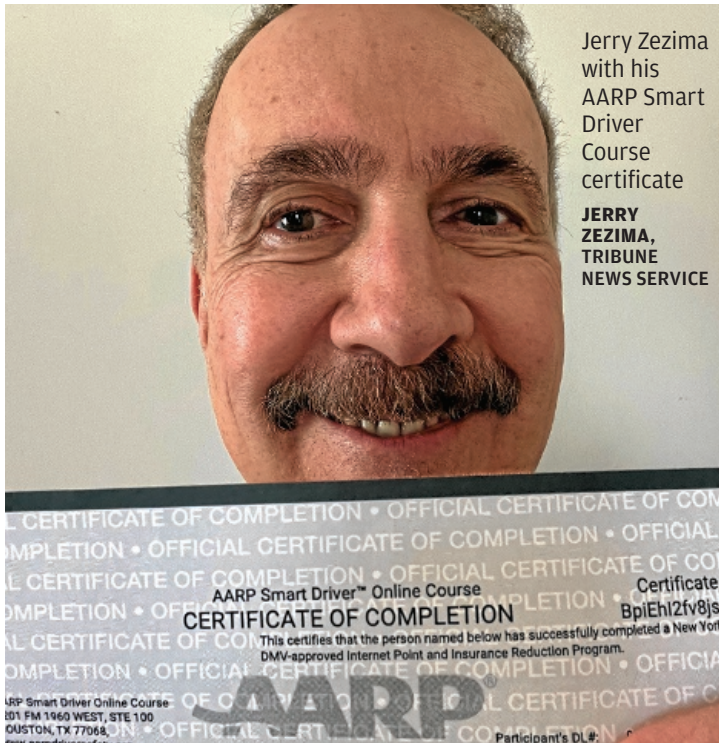

And I recently proved it by getting an A in an AARP Smart Driver Course.

I took the six-hour online class for one of the following reasons:

- If you guessed (c), you would be correct, although the first two were factors, as well. But Joe and Maria, who do voiceovers while their photos appear on the screen, aren't the only people participating in the course. Real-life seniors, including a married couple who argue while trying to figure out a map, appear in several videos.

One guy says, "The last thing I want to do is be a burden to my family, so I am going to keep driving for as long as I can."

It's a good thing I'm not in that video because I would have

said that being a burden is my goal. And if you ask my family, I achieved it long ago. That's why I am still driving.

I must say, however, that I got a lot out of the course. Yes, there's plenty of stuff I already knew, but it doesn't hurt to be reminded about such important things as how to depress the brake. (My guess: Insult it.)

People change as they get older (I changed my socks last week), and not everyone is at the same skill level when it comes to operating a motor vehicle.

Some people shouldn't be driving at all, especially the idiots who routinely blow through the stop sign in front of my house.

That's why I'm glad I paid attention through all six hours of the course. It helped me get 117 out of 125 questions right. That's a score of 94. In other words, I aced it. And I graduated — with a certificate — motor cum laude.

Chocolate may have benefits in moderation

Historians credit Richard Cadbury, son of chocolatier John Cadbury, with the invention in 1861 of heart-shaped boxes filled with chocolates.

The box — after the candy was consumed — was intended to store sentimental love letters or locks of hair, which were common practices in the Victorian era.

Of course, chocolate has been around much longer than heart-shaped boxes for Valentine's Day.

When first domesticated over 5,000 years ago in present-day Ecuador, cocoa beans were used to prepare a bitter-tasting beverage that was thought to give strength and sexual prowess to the drinker, according to Wikipedia. In fact, the Latin name for the tree that produces cocoa beans is *Theobroma cacao* L., which means "food of gods."

Time went on, and in 16th-century Europe, someone added sugar to chocolate. So here we are.

Contrary to popular opinion, chocolate is not an essential food group. It was, however, reported to be a vital part of rations for U.S. soldiers during the wars of the previous century. And when it comes to nutrition, there is some good news for those of us who adore this beloved treat.

Cocoa beans, from which chocolate is made, are rich in substances called polyphenols. Among other benefits, these antioxidant compounds have been shown in human studies to improve the flow of blood through arteries and assist in keeping blood pressure under control. In general, more polyphenols reside in cocoa powder and baking chocolate, followed by dark chocolate, semisweet and milk chocolate. And get this: Chocolate has been identified as a poly-

phenol-rich food, along with tea and wine.

And while I wouldn't necessarily recommend we eat chocolate for its nutrient content, it does contain a fair amount of essential minerals, including magnesium, iron and zinc.

Chocolate varies in fat content (check the label). But more than half the fat in products high in cocoa is in the form of healthful monounsaturated fats and stearic acid, a "good guy" saturated fat that may actually be good for our hearts, according to the USDA Food Data Central.

While scientists continue their grueling study of chocolate's attributes, several analyses of this most-loved food suggest that, eaten in moderation, chocolate may actually bestow some benefits to our health, according to a 2021 review published in the journal *Nutrients*.

How much is moderate? In 2021, researchers reporting in the *European Journal of Preventive Cardiology* calculated the association between chocolate consumption and the risk for heart disease in more than 300,000 people from six prospective studies. Their final tally was that "the benefits of nutrients in chocolate appear promising and chocolate consumption at least once a week may be beneficial for the prevention of coronary artery disease."

The City of Bismarck invites the public to comment on proposed substantial amendments to the 2019 Annual Action Plan. The 2019 Annual Action Plan outlines proposed activities to utilize the 2019 Community Development Block Grant (CDBG) funding to address the housing and community development needs identified in the 2015-2019 Consolidated Plan.

A 'substantial change' to the Annual Action Plan is defined by the City to be a) a change in the allocation priorities or goals identified in the Consolidated Plan; b) a change in the method of distributing funds (i.e. application process, selection criteria for projects, etc.); c) a proposed new project for the program year; or d) a change in the purpose, scope, location or type of beneficiaries of a project to such an extent that it can no longer reasonably be construed as the activity reviewed by the public and approved by the City Commission. - Modifications of Section AP-35 (Projects) to
- Remove \$11,130 in funds for a domestic violence shelter project canceled by Abused Adult Resource Center (AARC)
- Allocate \$11,130 in funds from the canceled AARC project to an AARC 2023 project, approved as a previous substantial amendment to the 2021 Annual Action Plan, for roof improvements at the intake location that serves individuals experiencing domestic violence.

Written Comment Period: The written comment period for the substantial amendments to the 2019 Annual Action Plan runs from Wednesday, February 14, 2024, through Friday, March 15, 2024. A draft of the amended document is available online at <https://www.bismarcknd.gov/1041/HUD-Grant-Programs>.

A Message from Garcia: Jessie James

The History and Culture of the Spirit Lake Dakota

By Louis Garcia © 12/31/12 (revised)

Most people associate the notorious bad man Jessie James and his gang with the State of Missouri; however, North Dakota and especially Spirit Lake tribal members also enter the grand play called history.

The James's North Dakota connection is vast and varied. There are so many twists and turns, names, and locations it is hard to know where to begin.

I first learned of Jessie James's connection to the tribe on January 19, 1981 when funeral direc-

tor John Burke told me that the Edward Lohnes family hid Jessie James at their home by Sweetwater Lake. He said the James Lamoreau family was also involved in protecting the James's. Mr. Burke said the dugout was located on the Jack McCarthy farm which I visited, but Jack knew nothing of the James brothers living there. Jack did show me the location of the Lohnes log house in his yard which he saw as a boy, having been torn down years ago. On January 24, 1981 I visited with Dennis Cavanaugh and his wife Susie. Dennis said he never heard of the James's hiding out in the area. He did say his mother fed the James and Younger gang when they were at Faribault, Minnesota salt pork and corn

storks and sub-zero weather.

Hollis was a railroad engineer until 1901. "When my wife left me, I threw up everything to look for her," he said. He searched Chicago until his savings ran out and then headed farther west.

He mentioned the gang shooting in the air when they came to town. The school teacher made her students sing to keep their minds off the shooting. Railroad buddies had given him free train rides for a while, but after 15 years, that was long over.

Now old, weak and hopelessly discouraged, Hollis was on his way home to die. Instead, the judge sentenced him to 35 days in jail. "I will ask

the superintendent to give you the best of care," the judge said. "It will be spring when you get out, and maybe you can walk to Port Huron then."

As the tale is woven, the James gang followed a trail on the west side of the Red River valley known as the McKenzie Drift. They stopped at an outlaw town east of Devils Lake called Bartlett before moving on to the Lohnes Homestead.

The City of Devils Lake was founded by a shady character named Herbert Creel whose mother was first cousin to General Stonewall Jackson. It is possible the James arrived in the Devils Lake

area in order to contact Creel. Creel is another story in itself. He was a West Point graduate who was stationed at Ft. Totten. He is accused of every early day criminal activity imaginable from swindling to robbery. His wife Alice Rue came from a southern sympathizer family too. Mrs. Olivia Kingree who wrote a historical column for the Devils Lake Journal, a six-part series, "Did you Know - the James Gang's Lake Region Connection", which focus's on Col. Creel. She was writing a biography of Creel. She has since moved away to parts unknown to me (Kingree 2006; Eriksmoen 2005).

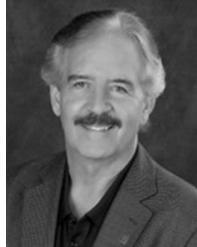

Cherry Pie Bars
Yield: One 9-by-13-inch pan

- 2 cups sugar
- 1 cup butter, softened
- 4 eggs
- 2 cups all-purpose flour
- 1 teaspoon baking powder
- 1/2 teaspoon salt
- 1 21-ounce can cherry pie filling

Preheat oven to 350 F. Line a 9-by-13-inch pan with parchment paper.

In a stand mixer, or with a hand mixer, cream sugar and butter on low. Add the eggs one at a time. Beat until just combined.

Add the flour, baking powder and salt. Spread a little over half the cake batter into the pan. Evenly spread the pie filling over the top, and spoon the rest of the cake batter over the pie filling. It's fine if the cherries show through.



Bake 35 minutes or until the top has turned slightly golden. Do not overbake. Allow to cool and slice into squares. Enjoy!

Notwithstanding the requirements of this section, a junk automobile or abandoned vehicle is subject to immediate impoundment without prior notice, as described above, when the city determines that the vehicle is otherwise parked unlawfully under section 14-35-11 or must be removed pursuant to section 14-35-05 due to a public emergency or other necessity.
