

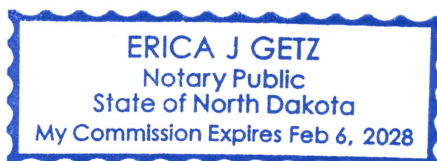

NOTICE OF RECEIPT OF REVISION APPLICATION

May 14, 2024

The Coteau Properties Company has filed an application for Revision No. 29 to Surface Coal Mining Permit No. NACT-0201 for the Freedom Mine. Revision No. 29 makes changes to the post mine topography for approximately 2,957 acres in Sections 3, 4, 9, 10, 11, 14, 15, and 16 of T145N, R88W. Revision 29 also updates the post-mining surface water probable hydrologic consequences and adjusts the post-mining land use in the N½ of Section 15, T145N, R88W. The introductory, legal, financial, compliance information, environmental, operations, and reclamation sections have also been revised.

You may submit written comments or objections on the proposed permit revision application, its effects on the environment and on surface owners of the land in the permit area. You may request an informal conference with the Commission and the applicant on the revision application. The reasons for requesting an informal conference must be stated in the request. Written comments, objections, or requests for informal conference must be made by July 6, 2024.

If there is an informal conference, you may request a formal administrative hearing on the Commission ruling on the application. Your request for a formal hearing must be made within thirty days of the Commission ruling on the application.
