NOTIFICATION OF APPLICATION

March 26, 2024

On January 8, 2024, Thunder Butte Pipeline, LLC filed an application with the Public Service Commission for a Certificate of Corridor Compatibility and Route Permit for a crude oil transmission pipeline. The project will consist of construction of an approximately 3.84-mile pipeline and the conversion of an approximately 30.8-mile existing gathering pipeline in Ward and Mountrail Counties, North Dakota, with approximately 3-miles of the new pipeline located within the Fort Berthold Indian Reservation.

On February 20, 2024, Thunder Butte Pipeline, LLC filed amended information related to their application indicating that it now proposes to modify its plan by constructing the midline pump station with an access road at a new location.


