APPLICATION OF THUNDER BUTTE PIPELINE, LLC TO PROTECT INFORMATION

Pursuant to 69-02-09-01 of the North Dakota Administrative Code, Thunder Butte Pipeline, LLC (TBPL), submits this Application to Protect from disclosure certain confidential information files with the North Dakota Public Service Commission ("Commission") in the above-referenced case. The purpose of this application is to protect from public disclosure cultural resource location information pursuant to North Dakota Administrative Code § 49-22-26. ("The Commission may limit access to, and release of, information that contains data the specifically identifies the location of cultural, archaeological, historical, and paleontological sites.")

Specifically, TBPL requests that protection be given to the cultural resource location information in the Cultural Resources Report in Appendix E of TBPL's Consolidated Application along with the associated GIS Shapefiles. Specifically, TBPL requests that this information be available only to the Commission, the Commission' counsel, the Commission' siting analysts, and the Administrative Law Judge.

Also provided is a compact disc containing non-public GIS Shapefiles.
