Preliminary Statement

[1] On April 2, 2024, Thunder Butte Pipeline, LLC (TBPL) filed an Application to Protect

Information und N.D.C.C. § 49-22-26 to protect certain information from public disclosure in this

proceeding. TBPL seeks to protect from public disclosure cultural resource location information.

Discussion

[2] The information TBPL seeks to protect includes the location of cultural resources in the

Cultural Resources Report located in Appendix E of the Consolidated Application and the

associated GIS Shapefiles. TBPL requests this information be available only to the Commission,

Commission counsel, Commission siting analysts, and the Administrative Law Judge.

[3] N.D.C.C. § 49-22-26 states, "the commission may limit access to, and release of,

information that contains data that specifically identified the location of cultural, archaeological,

historical, or paleontological sites."

[4] North Dakota Administrative Code section 69-02-09-03 provides "the commission staff

shall examine the information and application, and file and serve a response that includes a

recommendation on whether the information qualifies for protection."

- [5] Commission staff filed a response to TBPL's application on June 25, 2024. Staff believes that the application satisfies the requirements of the law, which allows the Commission to grant protection of information in this proceeding.
- [6] TBPL's application satisfies the requirements of the North Dakota Century Code for protection of the information, which is the subject of this request.

IT IS HEREBY ORDERED:

[7] The April 2, 2024 application of Thunder Butte Pipeline, LLC for protection of information is **GRANTED**.
