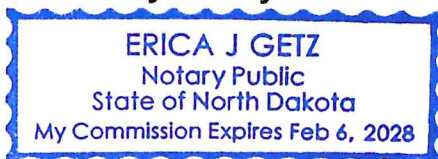

To the North Dakota Public Service Commissioners,

A utility-scale wind project can help transform local economies, which enhances the quality of life and opportunities in host communities.

The 250 MW Badger Wind Farm will have the capability to power nearly 90,000 homes over the course of the year, which will help meet the energy needs of North Dakota by providing reliable and flexible home-grown electricity. Orsted, a leading developer of wind and solar projects across the United States and globally, will construct, own, and operate the project.

The project is a long-term asset for Logan and McIntosh Counties. The Badger Wind Farm will inject a significant amount of new revenue into the tax base, which will promote local economic development in both counties.
