Dear Commissioners:

On May 21, 2025, I submitted a Petition and a Motion for Pro Hac Vice Admission in the above-referenced matter. The Motion was signed by my North Dakota local counsel. I am licensed to practice law in Minnesota, but not in North Dakota.

On May 27, 2025, I filed an amended petition that made no substantive changes to the body of the original petition. The only revision was to the caption, clarifying the forward-looking nature of the relief requested. That amended filing was accompanied by a cover letter and notice to the Commission and parties. No other pleadings have been filed since the May 21 petition and accompanying motion for pro hac vice admission, which remains pending.

By letter dated May 29, 2025, the North Dakota State Board of Law Examiners notified me that I have been assigned pro hac vice number P00392, for use if and when the Commission authorizes my admission.

On June 6, 2025, the Applicants, Otter Tail Power Company and Montana-Dakota Utilities Co., filed a response to the amended petition. Accordingly, a reply is due on June 13, 2025.

I respectfully write to inquire whether the Commission anticipates acting on the pending Motion for Pro Hac Vice Admission in advance of that June 13 deadline, or whether any additional information is required from me or from local counsel to facilitate action on the motion.

Attached is a Declaration Of Service indicating that this correspondence and copies are being served on opposing counsel and mailed to the Commission today.
