Appellants hereby file the North Dakota Supreme Court's March 5, 2026 Order in Supreme Court No. 20260059.

In that Order, the Supreme Court denied Appellees' motion to dismiss, denied Appellants' motion for limited remand as unnecessary, and directed that "the parties are directed to ensure a consistent judgment is promptly entered in the district court." March 5, 2026 Order ¶ 5.
