Your question revealed that there is an error in the letters to surface owners (Attachment IVa) and government agencies (Attachment IVb) that would cause some confusion to the recipients. This issue lies at the end of the first sentence, last paragraph of the letters, where it states the recipients have “within 30 days after receipt of this letter.” This is incorrect per NDCC 38-14.1-17(2) which stipulates that any person having a valid legal interest has within thirty days after the last publication of the notice to respond accordingly.

To correct this error, please amend the ending of the first sentence, last paragraph of the letters within Attachments IVa and IVb to read: “within 30 days after the last publication of the legal advertisement.”

Once these corrections are made, please resubmit Attachments IVa and IVb to the Reclamation Division. When we confirm these corrections, you may begin mailing the letters.

We apologize for not catching this earlier.
