NOTICE OF PRICE INCREASE

If applicable, effective on your next billing cycle, customers whose initial contract term has expired will see a monthly rate increase on Basic Business Lines, Centrex Lines, ISDN/BRI Lines, MEL (Market Expansion Line) Services/ Services Extended and Resale MEL Services. The increase will be dependent on type of service.

New base rates will be:

Basic Business Line - up to \$85.00

Resale Business Line, Resale Centrex Line, Resale ISDN/BRI - up to \$125.00

MEL Services/ Services Extended - up to \$50.00

Resale MEL - up to \$65.00


MEL Additional Pathway each - up to \$30.00
